Additional Information

New Zealand Climate Science Education Trust was placed into liquidation on 17 December 2013 on the application of National Institute of Water and Atmospheric Research Limited (NIWA). The trust was registered on 10 August 2010 and was set up with the intended purpose of promoting awareness and understanding into climate and environmental issues within New Zealand. The trust had initiated court proceedings in July 2010 in order to challenge the decisions and actions made by NIWA. The trust did not succeed on any of its challenges and an award of costs were subsequently ordered against them. The liquidator has been able to contact one of the three trustees of the charitable trust and he has thus far been co-operative with the liquidation. The liquidator intends to contact all of the trustees and is currently undertaking steps to ensure this process is completed. Should they refuse to assist they will be summonsed to attend a meeting to provide the necessary information. To date attempts to contact the applicant creditor have been unsuccessful. It appears the holiday period has delayed this process. The liquidator will continue efforts to contact the solicitor to obtain further information about the charitable trust. Searches and investigations conducted through various databases and other avenues have not revealed any assets. The investigations into the charitable trust are ongoing. If you are owed money, you can assist the investigation by registering a claim in this estate.
